You must complete the Free Application for Federal Student Aid (FAFSA) to receive consideration for all loan resources listed below. The FAFSA is completed online at **studentaid.gov** under the “Apply for Aid” tab. This will require only student information.

What resources are available to manage costs for the program?

1. Federal Direct Student Loan

- Unsubsidized—\$20,500 (no more than \$10,250 per semester)
- Processed using MPN already on file from undergraduate borrowing, if you attended Juniata College. If you did not previously borrow, Entrance Counseling & Master Promissory Note must be completed at **studentaid.gov** under the “Complete Aid Process” tab.

2. Federal Direct PLUS for Graduate Students

(You may borrow up to the cost of education after the Direct Student Loan.)

- Complete the Grad/PLUS application and Grad/PLUS Master Promissory Note at **studentaid.gov** under the “Complete Aid Process” tab.
- Must have no adverse credit history. May need a co-signer.
- Can defer principal payments while completing the program.

3. Private Alternative Education Loans

(Up to the cost of education after other resources.)

- Visit **juniata.edu/scholarship-resources** and choose “Financial Aid Resources” in the gold banner.
- May require a co-signer.
- Interest rates vary.
