#### Juniata's Outcomes

Since its inception in 2012, Juniata's Master of Accounting program has empowered over 90 percent of graduates to find accounting employment within six months of graduation. This is typical for some master's programs but is uncommon at smaller schools. In other words, our students enjoy one-on-one attention and still find jobs with prestigious employers, despite Juniata's student body numbering only around 1,600 students. It's just one reason that our alumni—like John Lash '08, who provided consulting to BP during an oil spill and still presents at leading conferences based on this experience—become industry leaders.

### A Master of Accounting Story

The Master of Accounting program is designed to prepare students for entry into a world where individuals must have a command of relevant knowledge about accounting, management, and economics, and have a capacity to apply that knowledge in addressing problems and making decisions.

Coursework emphasizes a firm understanding of accounting theories and concepts, and it's characterized by small, interactive classes. That close interaction with experienced faculty—the benefit of studying accounting at a liberal arts college—will help you develop the skills necessary to do well on the CPA examination and for a productive long-term career.

Complete the 32-credit graduate program in one year, by attending full time. Or, work through the course work on a part-time basis. Either way, accounting skills are highly valued in the marketplace and can lead to career possibilities in corporate settings, the non-profit sector, and government. But don't just take our word for it.
